Medals Awarded (for 1st, 2nd, and 3rd place in each class)

When: Saturday August 17th, 2019 9:00 am – 4:00 pm

Where: Sacramento Valley Gun Club, 15501 Meiss Road, Sloughouse, CA 95683

(access Meiss Road via Lone Road off of Jaskson Rd (Hwy 16) Note: GPS systems may route via Meiss Road west of the range. This route is nearly impassible for many passenger vehicles.)

Competitors May Shoot the Following District Competitions:

- 1) *Sporter Air Rifle .177cal - 3 Position*
- 2) *Smallbore Light Rifle .22cal - 3 Position*
- 3) *Black Powder Rifle - 2 Position*
- 4) *Shotgun – Trap Shoot (may use any shotgun 12 gauge or smaller)*

Separate Classes for Boys and Girls: (8-12yrs) – (13-17yrs) - (Adult 18 & over)

Cost: \$ 25.00 includes ammunition, loaner firearms, targets, ear & eye protection & range fees. \$10.00 range fee if you bring and use your own firearms and ammunition. No scopes allowed.

Bring your own lunch and beverages. Drinking water provided.

Rules: As published in the current Royal Rangers/NRA Postal Match rules (<https://thenssp.org/postal-competitions/>). All persons under 18 years must present signed parental permission slip (attached). Personally owned firearm equipment encouraged; loaner firearm equipment available (courtesy of the NRA Foundation Grant Program).

Competitors may use their scores for the Royal Rangers/NRA Postal Matches if they wish. (must meet NRA eligibility) Individual and Team RR/NRA Postal Match fees paid separately.

CALIFORNIA PENAL CODE SECTION 12551

S 12552: Furnishing Firearms to Minors under 18 without permission of parent.--Every person who furnishes any firearm, air gun, or gas-operated gun, designed to fire a bullet, pellet, or metal projectile, to any minor under the age of 18 years, without the express or implied permission of the parent or legal guardian of the minor is guilty of a misdemeanor.
